## PLAINTIFF'S NOTICE OF VOLUNTARY DISMISSAL WITH PREJUDICE

Comes now the Plaintiff, by and through counsel, and, pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(i), files this voluntary dismissal, stating as follows:

1. Plaintiff filed a Complaint in the United States District Court for the Eastern District of Pennsylvania against Defendant, which raised a 42 U.S.C. § 1983 claim, a First Amendment claim, a Fourteenth Amendment claim and Pennsylvania Religious Freedom Protection Act claim;

2. Defendant has revised Policy 220 to remove the following sentence entitled "Unprotected Student Expression:" "Seek to establish the supremacy of a particular religious denomination, sect or point of view;" and

3. Pursuant to a settlement agreement executed by the parties and attached as Exhibit A to Plaintiff's Unopposed Motion to Approve Settlement (Dkt. 22), and approved by this Court on October 15, 2014 (Dkt. 25), the parties have resolved all remaining issues in the case.

4. Each side shall bear its own costs except as otherwise provided in the settlement agreement.

Based upon the foregoing, Plaintiff hereby voluntarily dismisses this action with prejudice.
