**TEMPORARY RESTRAINING  
ORDER AND ORDER TO SHOW  
CAUSE IN SUPPORT OF  
PLAINTIFF'S APPLICATION FOR  
TEMPORARY RESTRAINING  
ORDER**

1 TO DEFENDANTS THE CENTER FOR MEDICAL PROGRESS, BIOMAX  
2 PROCUREMENT SERVICES LLC, DAVID DALEIDEN (aka "ROBERT SARKIS"), and  
3 TROY NEWMAN:

4 This matter comes before me on Plaintiff National Abortion Federation's (NAF") *Ex*  
5 *Parte* Motion for a Temporary Restraining Order and for an Order to Show Cause Regarding a  
6 Preliminary Injunction, Memorandum of Points and Authorities, and supporting papers.

7 Having considered the arguments and papers submitted, in order to preserve the status quo  
8 and finding good cause based on the record before me, I GRANT NAF's *Ex Parte* Motion,  
9 pending a hearing on Monday, August 3. Based on the record before me, I find that NAF is likely  
10 to prevail on the merits of its claims, the balance of hardships tips in its favor, NAF would be  
11 likely to suffer irreparable injury, absent an *ex parte* temporary restraining order, in the form of  
12 harassment, intimidation, violence, invasion of privacy, and injury to reputation, and the  
13 requested relief is in the public interest.

14 YOU ARE HEREBY ORDERED TO SHOW CAUSE on **Monday, August 3, 2015 at**  
15 **4:00 p.m.**, before the Honorable William H. Orrick, at 450 Golden Gate Avenue, San Francisco,  
16 CA 94102, Courtroom 2, why you, your officers, agents, servants, employees, and attorneys, and  
17 any other persons who are in active concert or participation with you, should not be enjoined and  
18 restrained from engaging in, committing, or performing, directly and indirectly, any and all of the  
19 following acts:

- 21 (1) publishing or otherwise disclosing to any third party any video, audio,  
22 photographic, or other recordings taken, or any confidential information learned, at  
23 any NAF annual meetings;
  - 24 (2) publishing or otherwise disclosing to any third party the dates or locations of any  
25 future NAF meetings;
  - 26 (3) publishing or otherwise disclosing to any third party the names or addresses of any  
27 NAF members learned at any NAF annual meetings; and
  - 28 (4) attempting to gain access to any future NAF meetings.

Pending hearing on the above Order to Show Cause you, your officers, agents, servants,  
employees, and attorneys, and any other persons who are in active concert or participation with

1 you ARE HEREBY RESTRAINED AND ENJOINED from:

- 2
- 3 (1) publishing or otherwise disclosing to any third party any video, audio,  
4 photographic, or other recordings taken, or any confidential information learned, at  
5 any NAF annual meetings;
- 6 (2) publishing or otherwise disclosing to any third party the dates or locations of any  
7 future NAF meetings; and
- 8 (3) publishing or otherwise disclosing to any third party the names or addresses of any  
9 NAF members learned at any NAF annual meetings.


10 NAF shall not be required to post a bond for issuance of this Order.

11 This Order and supporting papers must be served on Defendants as soon as possible, but  
12 no later than **August 1, 2015**. Any response or opposition to this Order to Show Cause must be  
13 filed and served on NAF's counsel no later than **August 3, 2015 at 12:00 p.m.**
