- 1. This Court hereby declares that Stayton Municipal Code §8.04.010, §8.04.160, and §8.04.180 were unconstitutionally applied to Frederick Pearson so as to restrict his expressive activities on June 26, 2009.
- 2. This Court hereby enjoins Defendants and their agents from applying Stayton Municipal Code §8. 04.010, §8.04.160, and §8.04.180 so as to require persons to obtain a permit to hold signs which convey non-commercial speech on public ways in the City of Stayton.
- 3. This Court hereby enjoins Defendants and their agents from applying Stayton Municipal Code §8.04.010, §8.04.160, and §8.04.180 to prevent persons from displaying signs with images of aborted babies on public ways in the City of Stayton.
- 4. Defendants shall pay the Plaintiff the amount of \$1.00 as nominal damages. Defendants shall also pay to Plaintiff's attorneys \$16,375.00 for fees and litigation costs. These payments shall be made within 90 days of the date this Order is signed.
- 5. The Court retains jurisdiction of this case solely to enforce the terms of this consent judgment.
