**COMPLAINT OF CIVIL RIGHTS VIOLATION**

Pursuant to the Illinois Human Rights Act ("Act"), 775 ILCS 5/1-10 to 5/10-104, the Complainant, Mark Wathen, by his attorneys, Betty Tsamis of Tsamis Law Firm, P.C. and John Knight of the Roger Baldwin Foundation of ACLU, Inc., complains of a civil rights violation against Respondent, TimberCreek Bed & Breakfast, as follows:

**JURISDICTION**

1. Complainant Mark Wathen ("Mark") is a gay man who filed charge number 2011-SP-2488 with the Department against Respondent on March 1, 2011.
2. On August 4, 2011, the Director issued a Notice of Substantial Evidence to the Complainant regarding the above-referenced charge.
3. This Complaint has been filed within ninety (90) days after receipt of the Notice of Substantial Evidence.

**THE PARTIES**

4. Complainant resides in Mattoon, Illinois with his civil union partner, Todd Wathen.

5. Respondent is a bed and breakfast located at 1559 East State Route 9, Paxton, Illinois 60957.

6. Respondent is business co-owned solely by Jim Walder and Beth Walder.

7. Respondent is a “place of public accommodation,” since it is “an inn, hotel, motel, or other place of lodging” and is not “an establishment located within a building that contains not more than 5 units for rent or hire and that is actually occupied by the proprietor of such establishment as the residence of such proprietor”, since it is a “place of public gathering”, and since it is an “establishment serving food or drink.” 775 ILCS 5/5-101(A)(1), (2) & (4).

### FACTS

8. Todd and Mark Wathen (“the Wathens”) have been a loving, committed couple for almost ten years, since January 2003.

9. The Wathens had been hoping for several years to be able to enter into a legally recognized union to both celebrate and protect their relationship with one another. As a result, they were excited to learn about the possibility that a civil union bill might become law in Illinois.

10. On January 31, 2011, Governor Pat Quinn signed legislation to make Illinois the sixth state to allow same-sex couples to enter into civil unions. The law had an effective date of June 1, 2011.

11. Following passage of the new law, the Wathens began looking for a location that would be convenient for their family members from Kentucky and Missouri to travel to, that had facilities for their civil union ceremony, and that had rooms where their family members could spend the night while in Illinois.

12. Todd Wathen (“Todd”) performed a Google search for possible locations for their civil union ceremony in Central or Southern Illinois and identified Respondent as a business offering wedding services and rooms where the Wathens’ family members could stay.

13. The Wathens agreed that Todd would contact Respondent to check on availability and, if possible, make reservations for rooms and arrangements for holding their ceremony at Respondent’s facility.

*Todd Wathen’s E-Mail Exchange with Mr. Walder*

14. On February 15, 2011 at 8:38 a.m., Todd sent an e-mail to Respondent requesting service. Specifically, he wrote:

“Do you plan on doing same sex civil unions starting on June 1st????”

A true and accurate copy of Todd’s e-mail exchange with Mr. Walder is attached hereto as **Exhibit A**.

15. Mr. Walder responded to Todd on February 15, 2011 at 9:05 a.m., via e-mail:

“No. We only do Weddings.”

16. Todd responded to Mr. Walder on February 15, 2011 at 9:15 a.m., via e-mail:

“starting june 1st, a civil union is a wedding, you have to get a licenses [sic] at the county clerks [sic] office, it is just not a marriage ...but a legal wedding....so aren’t you discriminating against me and my partner, because of our sexual orientation?????”

17. On February 15, 2011 at 9:27 a.m., Mr. Walder replied to Todd via e-mail:

“Civil unions and legal marriage are not the same thing, nor do they have the same legal status. We will never host same-sex civil unions. We will never host same-sex weddings even if they become legal in Illinois. We believe homosexuality is wrong and unnatural based on what the Bible says about it. If that is discrimination, I guess we unfortunately discriminate.”

18. Todd responded to Mr. Walder on February 15, 2011 at 9:44 a.m., via e-mail:

“On June 1st... There will be people getting Married that is having a wedding, and people having Civil Unions that will be having a Wedding... You still have to get a licenses [sic] for both, and you advertise for weddings, not marriage.... Well maybe I need to contact the IL Attorney General Dept. of civil rights and the State of IL Department of Human Rights, because you are a business and IL passed a law back in Jan. of 2006 for any business or employer, ect. [sic] not to discriminate against someone over there [sic] sexual orientation... and I do believe you are a business...and when you run a business... a person needs to keep their opinions to there [sic] self...”

19. Responding to Todd’s e-mail at 10:26 a.m. on February 15, 2011, Mr. Walder e-mailed:

“The Bible does *not* state opinions, but facts. It contains the highest laws pertinent to man. It trumps Illinois law, United States law, and Global law should there ever be any. Please read John 3:16.”

20. Between February 15, 2011 at 10:26 a.m. and February 18, 2011 at 9:14 a.m., the Wathens had no contact with Mr. Walder.

21. On February 18, 2011, at 9:14 a.m., Walder e-mailed Todd the following:

“I know you may not want to hear this, but I thought I would send along a couple of verses in Romans 1 detailing how the Creator of the Universe looks at the gay lifestyle. It’s not to [sic] late to change your behavior. He is loving and kind and is ready to forgive all men their trespasses, including me.

For this cause God gave them up unto vile affectations: for even their women did change the natural use into that which is against nature: And likewise also the men, leaving the natural use of the women, burned in their lust one toward another; men with men working that which is unseemly, and receiving in themselves that recompence [sic] of their error which was meet.”

22. After receiving this e-mail from Mr. Walder, the Wathens had no further communication

with Mr. Walder.

### *Respondent's Website*

23. Respondent maintains a public website – www.timbercreekbb.com – for the purpose of soliciting business.

24. Upon information and belief, Respondent's website has been maintained at the same domain during all relevant dates herein.

25. When Todd Wathen reviewed Respondent's website and prior to his email exchange with Walder,, Respondent's website represented that Respondent specialized "in creating wonderful outdoor country weddings, memorable for you and your guests." A true and accurate copy of Respondent's website on February 20, 2011 is attached hereto as **Exhibit B**.

26. On or about February 23, 2011, a condition followed this representation: "We do not host civil unions." A true and accurate copy of Respondent's website on February 23, 2011 is attached hereto as **Exhibit C**.

27. When Todd Wathen reviewed Respondent's website and prior to his email exchange with Walder Respondent's website represented that Respondent offered a "Civil Ceremony by Honorable Circuit Court Judge Steve Pacey on-site at TimberCreek: Free." A true and accurate copy of Respondent's website on February 20, 2011 is attached hereto as **Exhibit D**.

28. At a later time, a condition followed this offer: "Civil Unions: not available at TimberCreek." A true and accurate copy of Respondent's website on February 23, 2011 is attached hereto as **Exhibit E**.

29. When Todd Wathen reviewed Respondent's website and prior to his email exchange with

Walder, Respondent's website represented Respondent as an "upscale, sophisticated country Bed & Breakfast." A true and accurate copy of Respondent's website on February 20, 2011 is attached hereto as **Exhibit F**.

30. At a later date, this representation changed to represent Respondent as an "upscale Christian country Bed & Breakfast." A true and accurate copy of Respondent's website on April 27, 2011 is attached hereto as **Exhibit G**.

### **CIVIL RIGHTS VIOLATION OF THE ILLINOIS HUMAN RIGHTS ACT**

31. Complainant hereby incorporates by reference and re-alleges the above, paragraphs 1 through 30, as though fully set forth herein this claim.

32. The Illinois Human Rights Act ("Act") is intended to prevent and eliminate discriminatory practices in places of public accommodation because of an individual's sexual orientation. 775 ILCS 5/1-102(A).

33. Under the Act, a "place of public accommodation" is "an inn, hotel, motel, or other place of lodging, except for an establishment located within a building that contains not more than 5 units for rent or hire and that is actually occupied by the proprietor of such establishment as the residence of such proprietor." 775 ILCS 5/5-101(A)(1).

34. It is a civil rights violation under the Act "for any person on the basis of unlawful discrimination to . . . [d]eny or refuse to another the full and equal enjoyment of the facilities, goods, and services of any public place of accommodation." 775 ILCS 5/5-102(A).

35. On February 15, 2011, Respondent refused, withheld from, and denied Complainant the full and equal enjoyment of its facilities and services based on Complainant's sexual orientation. Respondent's denial to the Wathens of its facilities to hold their civil union ceremony and host


their guests and of its services was discriminatory based on their sexual orientation and had a disparate impact on them because of their sexual orientation.

36. As a result of Respondent's violation of the Act, Complainant has suffered substantial mental and emotional distress as well as the stigmatizing injury and deprivation of personal dignity that accompanies denials of equal access to places of public accommodation.

WHEREFORE Complainant respectfully requests the following relief:

- A. An order directing Respondent to cease and desist from any violation of the Act.
- B. Actual damages for the injury and loss suffered by Complainant;
- C. Interest on the Complainant's actual damages;
- D. An order mandating that Defendant pay Complainant's reasonable attorneys fees and costs pursuant to 775 ILCS 5/8A-104(G); and
- E. Any additional relief that the Commission deems just and appropriate.

**COMPLAINT OF CIVIL RIGHTS VIOLATION**

Pursuant to the Illinois Human Rights Act ("Act"), 775 ILCS 5/1-10 to 5/10-104, the Complainant, Todd Wathen, by his attorneys, Tsamis Law Firm, P.C. and John Knight of the Roger Baldwin Foundation of ACLU, Inc., complains of a civil rights violation against Respondent, TimberCreek Bed & Breakfast, as follows:

**JURISDICTION**

1. Complainant Todd Wathen ("Todd") is a gay man who filed charge number 2011-SP-2489 with the Department against Respondent on March 1, 2011.
2. On August 4, 2011, the Director issued a Notice of Substantial Evidence to the Complainant regarding the above-referenced charge.
3. This Complaint has been filed within ninety (90) days after receipt of the Notice of Substantial Evidence.

**THE PARTIES**

4. Complainant resides in Mattoon, Illinois with his civil union partner, Mark Wathen.

5. Respondent is a bed and breakfast located at 1559 East State Route 9, Paxton, Illinois 60957.

6. Respondent is business co-owned solely by Jim Walder and Beth Walder.

7. Respondent is a “place of public accommodation,” since it is “an inn, hotel, motel, or other place of lodging” and is not “an establishment located within a building that contains not more than 5 units for rent or hire and that is actually occupied by the proprietor of such establishment as the residence of such proprietor”, since it is a “place of public gathering”, and since it is an “establishment serving food or drink.” 775 ILCS 5/5-101(A)(1), (2) & (4).

### FACTS

8. Todd and Mark Wathen (“the Wathens”) have been a loving, committed couple for almost ten years, since January 2003.

9. The Wathens had been hoping for several years to be able to enter into a legally recognized union to both celebrate and protect their relationship with one another. As a result, they were excited to learn about the possibility that a civil union bill might become law in Illinois.

10. On January 31, 2011, Governor Pat Quinn signed legislation to make Illinois the sixth state to allow same-sex couples to enter into civil unions. The law had an effective date of June 1, 2011.

11. Following passage of the new law, the Wathens began looking for a location that would be convenient for their family members from Kentucky and Missouri to travel to, that had facilities for their civil union ceremony, and that had rooms where their family members could spend the night while in Illinois.



12. Todd performed a Google search for possible locations for their civil union ceremony in Central or Southern Illinois and identified Respondent as a business offering wedding services and rooms where the Wathens' family members could stay.

13. The Wathens agreed that Todd would contact Respondent to check on availability and, if possible, make reservations for rooms and arrangements for holding their ceremony at Respondent's facility.

*Todd Wathen's E-Mail Exchange with Mr. Walder*

14. On February 15, 2011 at 8:38 a.m., Todd sent an e-mail to Respondent requesting service. Specifically, he wrote:

"Do you plan on doing same sex civil unions starting on June 1st????"

A true and accurate copy of Todd's e-mail exchange with Mr. Walder is attached hereto as **Exhibit A**.

15. Mr. Walder responded to Todd on February 15, 2011 at 9:05 a.m., via e-mail:

"No. We only do Weddings."

16. Todd responded to Mr. Walder on February 15, 2011 at 9:15 a.m., via e-mail:

"starting june 1st, a civil union is a wedding, you have to get a licenses [sic] at the county clerks [sic] office, it is just not a marriage ...but a legal wedding....so aren't you discriminating against me and my partner, because of our sexual orientation?????"

17. On February 15, 2011 at 9:27 a.m., Mr. Walder replied to Todd via e-mail:

"Civil unions and legal marriage are not the same thing, nor do they have the same legal status. We will never host same-sex civil unions. We will never host same-sex weddings even if they become legal in Illinois. We believe homosexuality is wrong and unnatural based on what the Bible says about it. If that is discrimination, I guess we unfortunately discriminate."

18. Todd responded to Mr. Walder on February 15, 2011 at 9:44 a.m., via e-mail.:

“On June 1st... There will be people getting Married that is having a wedding, and people having Civil Unions that will be having a Wedding... You still have to get a licenses [sic] for both, and you advertise for weddings, not marriage.... Well maybe I need to contact the IL Attorney General Dept. of civil rights and the State of IL Department of Human Rights, because you are a business and IL passed a law back in Jan. of 2006 for any business or employer, ect. [sic] not to discriminate against someone over there [sic] sexual orientation... and I do believe you are a business...and when you run a business... a person needs to keep their opinions to there [sic] self...”

19. Responding to Todd’s e-mail at 10:26 a.m. on February 15, 2011, Mr. Walder e-mailed:

“The Bible does *not* state opinions, but facts. It contains the highest laws pertinent to man. It trumps Illinois law, United States law, and Global law should there ever be any. Please read John 3:16.”

20. Between February 15, 2011 at 10:26 a.m. and February 18, 2011 at 9:14 a.m., the Wathens had no contact with Mr. Walder.

21. On February 18, 2011 at 9:14 a.m., Walder e-mailed Todd the following:

“I know you may not want to hear this, but I thought I would send along a couple of verses in Romans 1 detailing how the Creator of the Universe looks at the gay lifestyle. It’s not to [sic] late to change your behavior. He is loving and kind and is ready to forgive all men their trespasses, including me.

For this cause God gave them up unto vile affectations: for even their women did change the natural use into that which is against nature:

And likewise also the men, leaving the natural use of the women, burned in their lust one toward another; men with men working that which is unseemly, and receiving in themselves that recompence [sic] of their error which was meet.”

22. After receiving this e-mail from Mr. Walder, the Wathens had no further communication

with Mr. Walder.

*Respondent's Website*

23. Respondent maintains a public website – www.timbercreekbb.com – for the purpose of soliciting business.

24. Upon information and belief, Respondent's website has been maintained at the same domain during all relevant dates herein.

25. When Todd Wathen reviewed Respondent's website and prior to his email exchange with Walder,, Respondent's website represented that Respondent specialized "in creating wonderful outdoor country weddings, memorable for you and your guests." A true and accurate copy of Respondent's website on February 20, 2011 is attached hereto as **Exhibit B**.

26. On or about February 23, 2011, a condition followed this representation: "We do not host civil unions." A true and accurate copy of Respondent's website on February 23, 2011 is attached hereto as **Exhibit C**.

27. When Todd Wathen reviewed Respondent's website and prior to his email exchange with Walder Respondent's website represented that Respondent offered a "Civil Ceremony by Honorable Circuit Court Judge Steve Pacey on-site at TimberCreek: Free." A true and accurate copy of Respondent's website on February 20, 2011 is attached hereto as **Exhibit D**.

28. At a later time, a condition followed this offer: "Civil Unions: not available at TimberCreek." A true and accurate copy of Respondent's website on February 23, 2011 is attached hereto as **Exhibit E**.

29. When Todd Wathen reviewed Respondent's website and prior to his email exchange with

Walder, Respondent's website represented Respondent as an "upscale, sophisticated country Bed & Breakfast." A true and accurate copy of Respondent's website on February 20, 2011 is attached hereto as **Exhibit F**.

30. At a later date, this representation changed to represent Respondent as an "upscale Christian country Bed & Breakfast." A true and accurate copy of Respondent's website on April 27, 2011 is attached hereto as **Exhibit G**.

### **CIVIL RIGHTS VIOLATION OF THE ILLINOIS HUMAN RIGHTS ACT**

31. Complainant hereby incorporates by reference and re-alleges the above, paragraphs 1 through 30, as though fully set forth herein this claim.

32. The Illinois Human Rights Act ("Act") is intended to prevent and eliminate discriminatory practices in places of public accommodation because of an individual's sexual orientation. 775 ILCS 5/1-102(A).

33. Under the Act, a "place of public accommodation" is "an inn, hotel, motel, or other place of lodging, except for an establishment located within a building that contains not more than 5 units for rent or hire and that is actually occupied by the proprietor of such establishment as the residence of such proprietor." 775 ILCS 5/5-101(A)(1).

34. It is a civil rights violation under the Act "for any person on the basis of unlawful discrimination to . . . [d]eny or refuse to another the full and equal enjoyment of the facilities, goods, and services of any public place of accommodation." 775 ILCS 5/5-102(A).

35. On February 15, 2011, Respondent refused, withheld from, and denied Complainant the full and equal enjoyment of its facilities and services based on Complainant's sexual orientation. Respondent's denial to the Wathens of its facilities to hold their civil union ceremony and host

their guests and of its services was discriminatory based on their sexual orientation and had a disparate impact on them because of their sexual orientation.

36. As a result of Respondent's violation of the Act, Complainant has suffered substantial mental and emotional distress as well as the stigmatizing injury and deprivation of personal dignity that accompanies denials of equal access to places of public accommodation.

WHEREFORE Complainant respectfully requests the following relief:

- A. An order directing Respondent to cease and desist from any violation of the Act.
- B. Actual damages for the injury and loss suffered by Complainant;
- C. Interest on the Complainant's actual damages;
- D. An order mandating that Defendant pay Complainant's reasonable attorneys fees and costs pursuant to 775 ILCS 5/8A-104(G); and
- E. Any additional relief that the Commission deems just and appropriate.
