## **ORDER**

By order entered on August 18, 2022, this Court obtained jurisdiction of this appeal from the Intermediate Court of Appeals of West Virginia under West Virginia Code § 51-11-4(b)(1) and Rule 1 of the Rules of Appellate Procedure. This appeal stems from a final order of the Circuit Court of Kanawha County (Case Nos. 22-P-24 and 22-P-26) entered on July 22, 2022. Briefing and consideration were expedited, and oral argument was scheduled for October 4, 2022.

On September 6, 2022, the petitioners Katie Switzer and Jennifer Compton, by counsel Michael A. Kawash and Jonathon C. Stanley, Robinson & McElwee PLLC, and Joshua A. House, Joseph Gay, and Jeff Rowes, Institute for Justice, filed a petitioners' brief. On the same day, the petitioner State of West Virginia, by counsel Lindsay S. See, Solicitor General, Michael R.

Williams, Senior Deputy Solicitor General, and Caleb A. Seckman, Assistant Solicitor General, filed a petitioner's brief and appendix record.

On September 23, 2022, the respondents Travis Beaver and Wendy Peters, by counsel Tamerlin J. Godley, Timothy D. Reynolds, Philip M. Hwang, Kiaura Clark, Zoe Lo, and Benjamin S. Gilberg, Paul Hastings LLP, John H. Tinney, Jr., Hendrickson & Long, PLLC, and Jessica Levin and Wendy Lecker, Education Law Center, filed a respondents' brief. On the same day, the respondents David L. Roach, State Superintendent of Schools, and L. Paul Hardesty, President of the West Virginia Board of Education, by counsel Michael W. Taylor, Kelly C. Morgan, and Harrison M. Cyrus, Bailey & Wyant, PLLC, filed a respondents' brief.

On September 30, 2022, the petitioners, by counsel, filed reply briefs. Oral argument was held on October 4, 2022, and the case was submitted for consideration.

Acting without undue delay given the nature of the constitutional matters at issue and the need to resolve the appeal in an expedited manner, the Court issues its decision by this order with a detailed opinion to follow. Chief Justice Hutchison and Justice Wooton would not enter a decision by order.

After careful consideration of all filings,<sup>1</sup> the record on appeal, and the oral arguments presented by the parties, the Court is of the opinion to, and does, dissolve the injunctive relief and reverse the order of the Circuit Court of Kanawha County entered on July 22, 2022.
