Recognizing the need for a strong, coordinated legal defense against growing attacks on religious freedom, more than 30 prominent Christian leaders launched ADF in 1994. Since that time, this unique legal organization has brought together thousands of Christian attorneys and like-minded organizations that work tirelessly to advocate for the right of people to freely live out their faith in America and around the world.

## A Leader in Freedom

#### A WINNING RECORD

Alliance Defending Freedom court victories have safeguarded the God-given, constitutionally protected right to religious freedom for thousands of Christians. Students, parents, business owners, employees, pastors, and community members who were previously censored or punished are now free to live out their faith.





ADF has played various roles in 61 victories at the U.S. Supreme Court and hundreds more in the lower courts.



## ADF Leadership

Michael P. Farris is president and CEO of Alliance Defending Freedom. As the second CEO of ADF, he brings to the role a diverse background as an effective litigator, educator, public advocate, and communicator, and is widely recognized for his successful work on both the national and international stage.

Farris was founding president of both the Home School Legal Defense Association (1983) and Patrick Henry College (2000) and continues to serve as chairman of the board of HSLDA and chancellor emeritus of PHC.

He graduated from Western Washington State College *magna cum laude* with a bachelor's degree in political science, followed by a Juris Doctor from Gonzaga University (with honors).

He also earned an LL.M. in public international law (with honors) from the University of London.

Farris has specialized in constitutional appellate litigation. In that capacity, he has argued before the appellate courts of 13 states, eight federal circuit courts of appeal, and the U.S. Supreme Court, where in 2018 he successfully argued *NIFLA v. Becerra*, resulting in a free speech victory for California's prolife pregnancy centers.

Farris has testified many times before both the House and Senate. He was an executive committee member of the Coalition for the Free Exercise of Religion that successfully lobbied Congress for the passage of the Religious Freedom Restoration Act of 1993. He also has substantial experience in international religious freedom advocacy.

Farris is the author of over 15 books, as well as law review and other scholarly and popular articles. He and his wife, Vickie, have 10 children and many grandchildren.



## The Next Generation

#### BLACKSTONE LEGAL FELLOWSHIP

Since 2000, Alliance Defending Freedom has trained more than 2,400 law students from more than 156 U.S. and 71 international law schools through the Blackstone Legal Fellowship. Blackstone is a leadership development program that brings together exceptional Christian law students and prepares them for careers marked by integrity, excellence, and leadership.

This nine-week summer program begins with two weeks of seminars on topics such as legal philosophy, constitutional law, and practicing the Christian faith within the legal profession. Interns then spend six weeks engaged in legal internships across the world, working with non-profits, governmental entities, and boutique law firms, among others. Blackstone Legal Fellowship concludes with a final week focused on career development and cultural engagement.

### Christian colleges fight lawsuit designed to strip their students of financial aid

EUGENE, Ore. - Alliance Defending Freedom attorneys representing three Christian post-secondary schools asked a federal district court Friday to allow them to intervene against a lawsuit that seeks to strip all students at private religious colleges of federal financial aid unless their schools renounce core religious beliefs. The suit, filed by a recently formed LGBT activist group on behalf of some current and former students, intends to prevent any students from using tuition grants, student loans, and any other federal financial assistance at schools that operate according to Christian beliefs on sexuality.
